Gianluca Perone – born in Rome, December 25th 1970 — graduated *summa cum laude* from Rome University "La Sapienza" Law Schools. He holds a PhD degree in Commercial Law from Rome University "Tor Vergata".

He is currently Professor of Commercial Law at Rome University "Tor Vergata", where he teaches Commercial Law and Bankruptcy Law.. Previously he taught Bank Law at Macerata University, Communication Law at Rome University "Tor Vergata", Commercial Law at Scuola Marescialli dei Carabinieri (Carabinieri non-commissioned Officers School) and Bankruptcy Law at Accademia della Guardia di Finanza (Guardia di Finanza's Officers College).

He is member of the Scientific Board of the PhD programme in Contracts, Services and Markets Theory at Rome University "Tor Vergata" and, previously, he has been member of the Scientific Board of the PhD programme in *Legal protections of Rights, Firms and Administrations* at the same University.

He has been Adjunct Professor at Macerata University and at Scuola Nazionale dell'Amministrazione (National School of Administration), Established Resaercher at Rome University "Tor Vergata" and Visiting Researcher at New York University.

Member of the Rome Bar. Admitted to the Bar of the High Court (Suprema Corte di cassazione). Member of the Arbitration Chamber of Rome Bar.

He provides legal advice to private and public companies, domestic and international financial institutions as well as private equity funds in relation to general commercial, financial, insolvency and communication matters.

He has been adviser to the Italian Ministry of Economic Development on matters relating the access to European Union Funding.

He has been appointed speaker at several national and international conferences on commercial law matters and he has published widely in the fields of commercial law.
